ELDER FRAUD ~~~ BE AWARE

WHAT IS ELDER FRAUD

It is defined as a financial fraud scheme which targets seniors.

COMMON ELDER FRAUD SCHEMES

- Romance scam: Criminals pose as interested romantic partners on social media or dating websites.
- Tech support scam: Criminals pose as technology support representatives and offer to fix non-existent computer issues.
- Grandparent scam: Criminals pose as a relative usually child or grandchild - claiming to be in immediate financial need.
- Government impersonation scam: Criminals pose as government employees and threaten to arrest or prosecute victims unless they agree
- Sweepstakes/charity/lottery scam: Criminals claim to work for a charitable organization to gain victims' trust, or claim a victim has won a foreign lottery or sweepstake, which they can collect for a "fee."
- Home repair scam: Criminals appear in person and charge homeowners in advance of home improvement services they never provide.
- TV/radio scam: Criminals target potential victims using advertisements about services, such as reverse mortgages or credit repair.
- Family/caregiver scam: Perpetrators are relatives or acquaintances of the elderly victims and take advantage of them or otherwise get their
- Investment scam: Criminals offer unsuitable investments, fraudulent offerings, and unrecognized products which can result in the theft or misappropriation of funds.

HOW TO PROTECT YOURSELF

NEVER provide any personal identifiable information. Resist the pressure to act quickly. Be cautious of unsolicited phone calls, mailings, and door-to-door service offers. **NEVER** wire money to unknown or unverified persons or businesses. Do not open any emails or click on attachments you do not recognize. Do not continue to communicate with the perpetrator.

ANNOUNCING A PROFIT PAYOUT

With the closing of 2022, the board of directors reflected on the past year. Even with so many unprecedented things still going on, the credit union has remained strong. We are pleased to say, the credit union closed out 2022 in excellent condition.

The Board of Directors would like to announce District One Highway Credit Union is declaring a

PROFIT PAYOUT of \$60,000

to be divided between a bonus dividend on share accounts/certificates and an interest refund for loans in good standing last year.

We want to thank those who choose to save with the credit union as well as those who borrow with us. It takes both to keep the credit union going strong!!!

The bonus dividend on shares and certificates will be calculated (in aggregate) and the interest refund will be calculated on all loans that have been in good standing during the past year and there will be a lump sum deposit into the regular share account. This excludes IRA accounts due to tax reporting issues. You will see this deposit in your account the first part of January 2023.
